Ethics Q&A

<u>Question:</u> A psychiatrist sees a patient at a reduced fee until the patient obtains insurance, and then bills the insurance company the full amount for subsequent sessions. Is this ethical?

<u>Answer:</u> If the doctor states the usual and customary fee to the patient at the beginning of treatment, but then reduces the fee given the patient's limited resources, it is not unethical to restore to a higher fee when the patient's financial situation improves, that is, the patient now has insurance coverage. (Section 2) (2018)


