child development, forensics and public health, he has an excellent foundation and experience to represent all of us.

Dr. Dube is also a member of the Council on Children, Adolescents and their Families and serves as the Selection Committee Chair for the APA Foundation (APAF)'s Child and Adolescent Psychiatry Fellowship. Anish works for the County of Orange's HealthCare Agency and provides direct clinical care to young people involved in the justice system. In the past few months, he participated as a panelist on two of the APAF's 'town hall' meetings and was featured on MedScape and NPR's Morning Edition on school reopenings and mental health.

Member Education, by John Luo, MD

The OCPS Education Committee, in partnership with our counterparts at the San Diego Psychiatric Society, has created monthly CME events which have been held over Zoom videoconference. This collaboration between SDPS and OCPS is going very strong and has been quite successful with over fifty attendees at these sessions. We have planned monthly 1.5 hour CME sessions through November 2021.



Previous topics have included professional use of social media, sleep medicine for psychiatrists, new ambulatory evaluation and management coding changes, and an overview of treatment of traumatic brain injury.
